### 2023 Melville Pavement Competition Rules

Welcome to the "Melville Pavement's Competition" competition (the "competition") conducted by the Melville Resident's Association or MRA ("Promoter"). These rules are the official rules of the competition ("rules"). These rules (together with any official competition communications) will govern and apply to the competition. Please take a moment to review these rules. By your participation, you agree that these rules will govern all aspects of your relationship with the competition and competition-related agents, and the Promoter. These rules can only be modified (or superseded) by Promoter (in its reasonable discretion) in a written revision to these rules posted on the competition website or (at Promoter's sole discretion) any other potential official competition communication methods reasonably calculated to reach a majority of potential participants.

# **Participation**

- 1. The competition is conducted by Promoter.
- 2. This competition is open to all legal residents of the Republic of South Africa
  - Submissions of pictures of pavements may be made by any legal resident of the Republic of South Africa
  - Winners will be the home-owners or tenants of the specific Melville property pictured in the submission – dependent on who is responsible for the pavement.

#### **Entries**

- 1. The competition will run from Thursday 5<sup>th</sup> October to 30 November 2023. No late entries will be accepted.
- 2. To enter the competition participants need to take a picture of their own or a neighbour's pavement and send it along with the address of the pavement to the MRA at <a href="mailto:pavement@ilovemelville.co.za">pavement@ilovemelville.co.za</a>
  - a. If a pavement is chosen as a winner, the pavement owner or tenant will need to give permission for their pavement and name to be published on social media
- 3. Participants can submit multiple entries.
- 4. There are 6 categories the judges will be looking to award winners in:
  - a. Indigenous Pavements
  - b. Water-Wise Pavements
  - c. Edible Plant Pavements
  - d. Beautiful Pavements
  - e. Pavements With Creative Use of Space
  - f. And a special category: Just Starting Out Pavements
- 5. Winners will be awarded from the entries received. There are 22 prizes and judges will be looking to find 22 winners from the submissions in the various categories
  - a. Note: we cannot guarantee a winner in each category as the winners are dependent on the entries received. Therefore, winners will be chosen at the judging panel's discretion and the judging panel will use the above-mentioned categories to make their selections
- 6. No responsibility will be accepted for entries lost, delayed or damaged in transmission.
- 7. Entries reflected on Promoter's records will be treated as the only validation source and will be the only evidence of successful entries.

## **Closing Dates**

- 1. Entries must be received by Promoter no later than 11pm on 30<sup>th</sup> November 2023.
- 2. Judging will commence on 1 December 2023 and winners will be announced no later than 15 December 2023.

- 5. The prizes are not transferable and cannot be exchanged for cash
- 6. In the event of the Promoter not being able to contact the chosen winner, the Promoter reserves the right to choose an alternative winner
- 7. Promoter reserves the right to substitute a prize of equal or greater value if the original prize is unavailable.
- 8. Promoter is not responsible for any damaged prize items after signature of receipt.
- 9. The prize may be subject to additional terms and conditions that the prize winner must comply with.
- 10. Every entry will be collected and given to the judging panel who will choose the best pavements in the above-mentioned categories.
- 11. The judges are:

  - d. Lousie Daneel: Owner of Auckland Park Florist
- 12. The judges are not part of the MRA.

- 13. Prize winners may be requested to participate in publicity connected to this competition. The prize winners grant permission for the use of the pictures of their pavements in any advertising and promotional material for this competition.
- 14. Participants and the winner absolve the Promoter, its affiliates, its advertising agencies, advisors, suppliers, nominated agents and dealers from liability from any and all claims howsoever arising, including from wilful misconduct or negligent acts or omissions on the part of any such person.
- 15. The Promoter reserves the right to alter or cancel the competition at its discretion, without recourse.

### General rules

- 1. The participant unconditionally and irrevocably indemnifies and holds harmless Promoter and its successors, employees, officers, suppliers, contractors, agents, consultants, directors and shareholders against all and any losses, claims, proceedings, actions, damages, (direct, consequential or otherwise), liability, demands, expenses, legal costs (on an attorney and own client basis), medical costs or other costs howsoever arising out of, based upon, or in connection with (directly or indirectly) the participants participation in the competition, to the maximum extent permitted by law.
- 2. If a participant contravenes these rules, the participant may, in Promoter's discretion, be disqualified from the competition.
- 3. The judge's decision is final and no correspondence will be entered into.
- 4. Income taxes relating to the prizes, if any, are the sole responsibility of the prize winners.
- 5. The laws of the Republic of South Africa govern this competition.
- 6. Promoter reserves the right to cancel or alter any aspect of the competition at any time at its sole discretion without liability.
- 7. Participants in the competition understand and agree that in order to offer the competition; Promoter must collect and use personal information about participants. This competition is conducted under the terms of applicable privacy statements and POPI regulations.

These terms and conditions are subject to change according to the promoter's discretion.
